Below is the information that the Accademia Musicale Chigiana, as Data Controller, uses for business in relation to the fact that personal data acquired in dealings with third parties, related to its activity aimed at pursuing statutory objectives, are (as regards the management of personal relationships), in a lawful and correct manner and kept in compliance with EU security obligations) 2016/679), henceforth the "Regulation".

INFORMATION OF THE INTERESTED PARTY (Student, Lecturer, Artist, Supplier, Spectator, etc.) TO THE SENSES EX ARTT. 13-14 GDPR UE / 2016/679 ADAPTATION OF THE NEW EUROPEAN REGULATION.

The European Regulation UE / 2016/679 (hereafter "Regulations") establishes rules concerning the protection of individuals with regard to the processing of personal data. In compliance with the principle of transparency provided for by art. 5 of the Regulations, **the FONDAZIONE ACCADEMIA MUSICALE CHIGIANA VIA DI CITTÀ' 89 53100 SIENA - ITALY as Data Controller, provides you the information required by articles 13 and 14 of the Regulations.**

PURPOSE OF THE TREATMENT

The processing of **your personal data** will be based on principles of correctness, lawfulness and transparency, protecting **your privacy, your rights and in accordance with the privacy policy.**

THE FONDAZIONE ACCADEMIA MUSICALE CHIGIANA undertakes not only to retain the data in accordance with the principle of "minimization", or by acquiring and processing data limited to what is necessary with respect to the following purposes:

- a) Insertion of your data into the database of the Accademia Musicale Chigiana Foundation in order to allow monitoring;
- b) Management of fiscal, administrative and accounting obligations;
- c) Compliance with obligations under the law, regulations and EU legislation;
- d) Marketing activities through the creation and dissemination of promotional and advertising material (paper, video, digital, etc.) related to the concert and artistic activities developed ;
- e) Direct marketing activities (with the sending of promotional and advertising material) through the use of both traditional methods of contact (eg calls with operator, mailing) and automated methods (eg SMS, email, etc.).

However, you may object to this processing from the beginning or at the time of subsequent communications, including by means of an informal request to be sent to the Data Controller; the provision of your personal data is mandatory for the purposes mentioned above and your refusal to provide data will make it impossible to continue the relationship.

PROCESSING METHODS

The processing of your personal data will be carried out using paper and computerized methods in compliance with the provisions on the protection of personal data and, in particular, the appropriate technical and organizational measures referred to in Article 32.1 of the Regulations, and with the observance of each precautionary measure that guarantees its integrity, confidentiality, availability.

TRANSFER OF DATA ABROAD

Your personal data will be processed by the FONDAZIONE ACCADEMIA MUSICALE CHIGIANA within the territory of the European Union.

If for technical and / or operational reasons it is necessary to make use of subjects located outside the European Union, or it is necessary to transfer some of the data collected to technical systems and services managed in the cloud and located outside the area of the European Union, the processing will be regulated in accordance with the provisions of Chapter V of the Regulation and authorized on the basis of specific EU decisions. All necessary precautions will therefore be taken to ensure the most complete protection of personal data by basing this transfer: a) on adequacy decisions of the third country recipients expressed by the European Commission; b) on appropriate guarantees expressed by the third party to be received.

CATEGORY OF THE ADDRESSEES

Your personal data may be communicated, in strict relation to the purposes indicated above, to the following subjects or categories of subjects:

a) to subjects in relation to which the current regulations provide for the obligation to report, in compliance with the provisions of the fiscal legislation, accounting and financial reporting system management,

b) to credit institutions or third parties for the management of collections and payments deriving from the execution of contracts,

e) to professionals (both natural and legal persons) to whom the Data Controller should entrust tasks for the performance of some outsourced activities (eg accountants, consultants, privacy consultants).

Furthermore, your data will be processed exclusively for the aforementioned purposes, by the person in charge of the company, specifically authorized and instructed by the owner in accordance with Article 29 of the Regulations.

Your personal data will not be disclosed, except where required by a rule of law or regulation or by community legislation.

RIGHTS RECOGNIZED TO THE INTERESTED PARTY

At any time you can exercise, towards the owner, your rights as per articles 15-22 of the Rules.

- 3) cancellation;
- 4) the limitation of their treatment.

You will also have the right:

- a) to oppose for legitimate reasons the processing of data if processed for the pursuit of a legitimate

- interest of the Data Controller, if it considers violated their fundamental rights and freedoms;
- b) to revoke your consent at any time in relation to the purposes for which this is necessary;
 - c) to the portability of your data, that is the right to receive, in a structured format, in common use and readable by an automatic device, the personal data referred to you;
 - d) to propose a complaint to the supervisory authority (Garante Privacy/Privacy Guarantor).
